



# FEDERALLY ASSISTED FAMILY HOUSING PROPERTIES

The minimum requirements for eligibility are based on the following categories. Please note that each agency may have differences in their policies:

- Income: Families with Low Income (annual income does not exceed 80% of the median income for the area) are eligible. Preference may be given by some agencies to Very Low (does not exceed 50%) and Extremely Low Income (does not exceed 30%) families.
- Citizenship: At least one member of the household must have permanent legal residency.
- Sex Offenders: No person on the lifetime sex offender registry is eligible for Federally Assisted Housing.
- Criminal Activity: Different between agencies; Prior criminal activity may affect your eligibility. Persons participating in current drug activity are ineligible. Past drug or violent criminal activity could affect eligibility based on the time the offense occurred.
- Determination of unit size: Different between agencies; Custody of a minor is handled differently between agencies.
