Dear the City of Green Bay Clerk's office,

Pursuant to Wisconsin's open records law, I request access to and a copy of all records that pertain to:

- Any and all information regarding what types/brands and model number of election machines the City of Green Bay used on November 3<sup>rd</sup> and November 4<sup>th</sup> for the November 3<sup>rd</sup>, 2020 election and which wards they were counting – either the ward number or at central count. If the machines were moved, we would like all information on the original ward or at central count they were in and the ward or at central count they were moved to in the City of Green Bay.
- Any and all information regarding software updates from November 1 – November 13 that pertain to the election machines that were used in the City of Green Bay on November 3<sup>rd</sup> and November 4<sup>th</sup> for the November 3<sup>rd</sup>, 2020 election.

The scope of this request includes all forms of the information.

The search for records for the FIRST bullet point may be limited to those sent, received, and collected between November 3 and November 4.

The search for records for the SECOND bullet point may be limited to those sent, received, and collected between November 1 and November 13.

I request that these records be provided in electronic form. As this request is an official request from another branch of government we respectfully ask that you waive any fees associated with this request. If said fees are not waived, please inform us if they exceed \$100. Please provide a receipt indicating the charges for each document.

We kindly request that you inform us once you receive this request and begin processing it. Thank you.
